**TITLE:** Habitat Credit Exchange Program

### **STORY DESCRIPTION:**

Panoramaland, Color Country RC&D and Partners have developed the Habitat Credits Exchange Program, a habitat bank. The HCEP is one facet of a multi-pronged effort working towards habitat & species conservation and future delisting of the Utah prairie dog, a species listed as *Threatened* under the provisions of the ESA.

### **TOTAL PROJECT VALUE:**

To date \$552,000

### **RETURN ON FEDERAL INVESTMENT:**

100% return is estimated. We anticipate doubling the original grant investment and to be self-funding by 2012 year-end.

### **OUTCOMES:**

This innovative market-based recovery credit system provides financial incentives for private agricultural producers to voluntarily preserve habitat through conservation easements while retaining title and agricultural use. This approach will provide clearance from ESA, accelerate development, and speed permitting time while it also advances recovery prospects for this species by facilitating private agricultural producer involvement thus provides contribution to the recovery and delisting of the species.
